

**Agreement of Cooperation
between
Cuiavian University in Włocławek
(Republic of Poland)
and
Stepan Gzhytskyi National University
of Veterinary Medicine and Biotechnologies Lviv
(Ukraine)**

The following Universities: Cuiavian University in Włocławek in the person of the Head of Didactic Office Joanna Szulerecka and Stepan Gzhytskyi National University of Veterinary Medicine and Biotechnologies Lviv in the person of the Dean of Faculty of social development and health Ruslan Peleno desirous to foster their current relations both in academic research and teaching fields; desirous to mutually respect and to benefit from this cooperation; have chosen to set up an agreement and approve of the terms of the following Agreement of Cooperation.

Article 1

The purpose of the present agreement is to foster the education and research opportunities for students of pedagogical specialties and students of physical therapy, ergotherapy and University staff and provide opportunities for cultural exchange within the domains of each University.

Article 2

Within the fields of common interest, both Universities shall undertake to:

- exchange information necessary for educational and research activities, including advising on the development of new educational programmes;
- organize meetings, symposiums, seminars and conferences in cooperation;
- carry out joint academic and research projects;
- exchange of academic staff and internships;
- work in cooperation at developing and implementing the joint/double diploma programs (Bachelor–Master–Doctorate);
- conduct the joined PhD supervision in accordance with the subject that are available in the partner university;
- organize academic mobility of the University staff and students.

Article 3

The Universities agree that the development of cooperation (i.e. collaboration between research centers) between the Universities will be the object of programs drawn up in collaboration and submitted to the competent authorities of the Universities.

Article 4

The present Agreement does not provide for financial obligation. The Universities will procure, on their own, the financial funding needed to carry out the aims of the Agreement. They will try to obtain part of the funding required for the carrying out of the present Agreement and strive to obtain additional funding. The order and terms of funding of joint projects are to be on a project-by-project basis.

Article 5

The two universities will be responsible for the publication, commercial exploitation and protection of the intellectual production of their collaboration. This will be carried out in accordance with the conventions concerning intellectual and industrial property rights which presently exist in the respective countries.

Article 6

The present Agreement can be cancelled at any time, by either party, within six months of its notification.

The present Agreement cannot be modified or amended without mutual agreement of both Universities. All modifications and amendments should be stated in written form and signed by the Universities.
